

ARCHITECTURAL CONTROL NOTICE

Homeowners are required to submit an “Application for Architectural Change” form to the HOA if you are planning to make updates, replacements or other improvements to the exterior of your home or property; **even if you are replacing or updating with similar products or the same paint colors.** Anything visible on the outside of your house or within the yard must be submitted for approval to the Architectural Control Committee (ACC) as our covenants require.

Applications must be accompanied by complete plans, sketches, samples, color chips and/or other pertinent information so that the ACC has as complete an idea of your project as possible. When requesting fence changes, sheds, accessory buildings, or play structures, also submit a drawing of your yard showing the location of the fence or item and indicate the material, height and style of the proposed fencing, shed or structure.

Regular Board Meeting September 10, 2013 – Unofficial Minutes

CALL TO ORDER: President, Chris Raab, called the meeting to order at 6:36 p.m. Board Members present were Mary Anne Buczyna and Cole Wist; as well as Pool Manager, Jaylene Jones; Landscape Manager, Nancy Bauer; and Business Manager, Katie Kidwell. Swim Team Parent Representatives Erik Steinberg and Gregory Steinmetz also attended a portion of the meeting.

MINUTES: The minutes of the August 13, 2013 meeting were approved as read.

SWIM TEAM: Parent Reps Gregory Steinmetz and Erik Steinberg reported that the Hurricanes had 236 swimmers in 2013. The July 4th and Movie Night events were well attended and successfully raised funds so that they expect to break even for the year. The Hurricanes plan some changes for 2014: they hope to develop the 6 & under segment of the team and make some minor changes to the Tuesday night STAR meets. They also plan to change their hiring process. The parent reps will hire a head coach first and include the head coach in the interviews for the remaining coaches. Hiring for the head coach will take place during the Thanksgiving break and all other coaches will be hired over the Christmas break. The parent reps are looking at new vendors for spirit wear and swim suits and are considering new software for registration. Cole asked if there were any concerns about the pool itself. Erik mentioned the Hurricanes needed new lane line ropes. The Board agreed to supply those for the swim team.

MANAGER REPORTS

1. **POOL:** Pool Manager Jaylene Jones reported that all the pools were covered. Some furniture remains on the decks and will stay there until the bathrooms are winterized. All the pergola covers have been removed and stored. Jaylene submitted a proposed 2014 budget noting that capital expense items had been prioritized. Most pressing were a new heater circulation pump and changing sand in the filters. Jaylene noted that the North Pool would also need a new boiler soon.
2. **LANDSCAPE:** Landscape Manager Nancy Bauer reported that she planned to plant two trees and install new sod in some areas. She has also refrained from planting a bed near the stairs at Costilla Avenue due to drought restriction, but would now proceed with planting. More perimeter fence painting would also occur in October. Nancy presented a proposed 2014 budget to the Board.

3. **TENNIS:** Tennis Manager Melissa Shuck was absent. Chris Raab reported that an engineering meeting was scheduled with LERenner Sport Surfaces for the week of September 9th and that demolition of the West Courts should begin the following week.

4. **BUSINESS:** Business Manager Katie Kidwell reported on the status of dues collection. She informed the Board that the Association's Collection Policy needed to be updated to conform to changes in Colorado state law. Cole moved and Mary Anne seconded a motion to have the Association attorney update the policy for a fixed fee of \$130. The motion passed unanimously. Katie presented her proposed 2014 budget to the Board.

FINANCIAL REPORT: No report was made as Treasurer Aloah Kincaid was not in attendance. Financial Statements for August are available at the Business Office for any homeowners who wish to review them.

HOMEOWNER COMMENTS: The owners of account # 420 approached the Board to appeal an ACC directive that they paint the trim of their house with the trim color approved by the ACC. The owners received approval for body, trim and accent colors but decided to paint the trim of their house with the body color because they believed it made their house look bigger. The ACC had approved the body color assuming it would be offset with a more neutral trim color and that the trim color would be applied in the same places that the trim existed before re-painting. Chris explained that the Board and ACC are often caught between being unambiguous in their communications and being perceived as overly picky or even hurtful by homeowners. The Board acknowledged that the ACC application was approved and did not contain specific language identifying which items were considered to be the trim which the homeowners would paint with the trim color. They asked if the homeowners were willing to accede to the ACC request that they paint their trim with the approved trim color. The homeowners did not want to do so. The Board discussed whether applications and approvals by the ACC would have to be revised to be more specific going forward if homeowners were going to rely on loopholes to circumvent ACC decisions.

OLD BUSINESS: A revised draft of the proposed Dispute Resolution Policy was reviewed by the Board. Cole moved to approve the policy as drafted. Mary Anne seconded the motion which passed unanimously. The Board discussed perimeter fence maintenance and reviewed a letter to send to homeowners who share the perimeter fence with the HOA. The purpose of the letter is to educate homeowners as to their responsibility for the maintenance of the perimeter fence and give them time to correct any landscaping that could damage the wood of the fence. The Board directed Katie to mail letters to perimeter fence homeowners immediately.

It's amazing what it takes to provide a quality education for 51,308 students! Here are some fun facts from the start of the 13-14 school year, as presented to the Board of Education on Sept. 9 by Dr. Scott Siegfried, Associate Superintendent for Educational Operations.

LANDSCAPE LOGIC

Fertilize and aerate your lawn:

Cool season grasses will green up faster in the spring when they are fertilized in the fall. Use a lawn fertilizer that has plenty of nitrogen, less phosphorous and potassium. Some examples would be 20-10-5, 11-5-5, or 21-7-11. After the stresses of summer, grasses need to build carbohydrate reserves to endure the winter; it is nitrogen that is needed to promote carbohydrate production.

Aeration stimulates root growth and improves nutrient uptake. Aeration allows oxygen, water and nutrients to penetrate further into the soil, encouraging deeper roots and reducing soil compaction that restricts root growth.



Don't prune trees and shrubs:

Avoid the temptation to prune trees and shrubs in late fall. Deciduous trees and shrubs, as well as evergreens, do not have the ability to close up wounds when they are dormant or semi-dormant. Heavy pruning should be accomplished in mid to late spring, when plants can rapidly heal pruning cuts.



Protect trees from sunscald

damage: 'Sunscald' is a term referring to dead tree tissue occurring from direct sunrays heating up tree tissue in mid winter and freezing nighttime temperatures that kill the activated tissue. This is a severe threat to newly planted trees; consequently, they should receive protection for at least (2) years.

Commercial tree wraps are an effective method of preventing sunscald damage. Starting at the trunk's base, overlap the wrap as it is applied upward to a point above the second branch. Attach the wrap at the top and bottom with a single tack or electric tape. This

wrap will need to be removed in mid April to prevent insect damage.

Early Frosts:

Now is the time to begin paying attention to the weather forecasts for predictions of early frosts. Cover plants if necessary.

It is also time to bring in your houseplants that have been outdoors for the summer. Clean them first by hosing them down with a gentle stream of water. This will clean the foliage and dislodge insect pests and their eggs. Check the underside of the containers for, earwigs, millipedes and other insects that can piggy back inside and become nuisance pests.



Don't Forget to Water:

Especially new plantings, but also anything in your landscape, water every 3-4 weeks throughout fall and winter if we have no snow cover. Our soils can become extremely dry during winter and roots still need to have moisture to survive.

Evergreens can also benefit from a 'water scrub'. Use a nozzle that will let you apply a strong, full force spray; start at the top of the plant and work downward. Scrubbing will remove summer's build up of dust and pollution, freeing up the little 'breathing holes (stoma) in the needles. That leads to healthier trees with less stress.

Water scrubbing also washes off insects such as aphids and spider mites, loose scale insects and eggs along with dead brown needles.



Faucet Fixes Conserve water:

Did you know that one drip per second of water equates to 220 gallons a month? So it makes sense to stop the drops wherever we can. Take time to inspect all your outdoor faucets and connections now as we face the freezing temperatures of winter. I feel better knowing I'm averting potential problems early and doing my part to save water!



HOMESTEAD HURRICANES

During the 2013 Homestead Hurricanes Swim Team end of season celebration the coaches had the privilege of handing out the awards to each age group. 

Council approves ballot question for November election

(Centennial, COLO) Last evening, the Centennial City Council decided to include a question relating to the City's ability to use its existing fiber optic network on this November's ballot.

This November, Centennial voters will elect a mayor and one city council member from each of the City's four districts. Additionally, there will be a question on the ballot which relates to the City's ability to use its existing fiber optic network. This question will read as follows:

SHALL THE CITY OF CENTENNIAL, WITHOUT INCREASING TAXES, AND TO RESTORE LOCAL AUTHORITY THAT WAS DENIED TO ALL LOCAL GOVERNMENTS BY THE STATE LEGISLATURE, AND TO FOSTER A MORE COMPETITIVE MARKETPLACE, BE AUTHORIZED TO INDIRECTLY PROVIDE HIGH-SPEED INTERNET (ADVANCED SERVICES), TELECOMMUNICATIONS SERVICES, AND/OR CABLE TELEVISION SERVICES TO RESIDENTS, BUSINESSES, SCHOOLS, LIBRARIES, NON-PROFIT ENTITIES AND OTHER USERS OF SUCH SERVICES, THROUGH COMPETITIVE AND NON-EXCLUSIVE PARTNERSHIPS WITH PRIVATE BUSINESSES, AS EXPRESSLY PERMITTED BY ARTICLE 29, TITLE 27 OF THE COLORADO REVISED STATUTES?

POLICY REGARDING DISPUTE RESOLUTION

Adopted September 10, 2013

The following procedures have been adopted by Homestead in the Willows Homeowners Association, Inc. (“Association”) pursuant to the provisions of C.R.S. 38-33.3-209.5 at a regular meeting of the Board of Directors.

Purpose: To provide a more efficient means of resolving disputes or claims involving the Association and/or the Association’s governing documents and to reduce the costs and fees associated with dispute resolution.

WHEREAS, the Colorado Common Interest Ownership Act, in C.R.S. 38-33.3-124, encourages common interest communities to adopt protocols that make use of mediation in resolving disputes between the Association and one or more unit owners.

NOW, THEREFORE, IT IS RESOLVED that the Association does hereby adopt the following policy governing the resolution of disputes:

1. **Dispute Resolution Procedures**. Except as otherwise provided in this policy, the following procedures will be followed in all disputes or claims involving the Association and/or the Association’s governing documents.


A. Prior to proceeding with any claim, the party asserting the claim (“Claimant”) shall give written notice of such claim to all opposing parties (“Respondent”), which notice shall state plainly and concisely:

- (i) the nature of the claim, including all persons involved and Respondent’s role in the claim;
- (ii) the legal or contractual basis of the claim (i.e. the specific authority out of which the claim arises); and

- (iii) the specific relief and/or proposed remedy sought.

B. After the Respondent receives the notice of claim, the parties shall make every reasonable effort to meet in person and confer for the purpose of resolving the claim by good faith negotiation. Such efforts may include inspections of the Claimant's or the Respondent's Lot for purposes of evaluating any alleged violation. Any party may be represented by attorneys and independent consultants to assist in the negotiations and to attend meetings.

C. If the parties do not resolve the claim through negotiations within sixty (60) days after submission of the claim to the Respondent, the parties shall make a good faith effort to submit the claim for mediation. In the event the parties are unable to agree on a mediator, a mediator shall be appointed upon application of either party to the District Court of Arapahoe County. In such event, the claim shall be deemed to be submitted upon filing the petition for appointment of the mediation.

D. Any settlement of the claim through mediation shall be documented in writing by the mediator and signed by the parties. If a termination of the mediation occurs, the mediator shall issue a written statement advising that the parties are at an impasse.

E. Unless otherwise agreed, each party shall bear its own costs of the mediation, including attorneys' fees, and each party shall share equally all charges of the mediator.

F. Upon termination of mediation if no resolution is reached, if Claimant desires to pursue the claim, Claimant shall thereafter be entitled to file an action in any court having jurisdiction in Arapahoe County for final resolution of the claim.

G. In any action, the court shall award the substantially prevailing party its reasonable costs and attorneys' fees.

2. Exclusions. Unless all parties to the actions outlined below otherwise agree, the following disputes or claims shall not be subject to the provisions of this policy:

A. An action by the Association relating to the collection or enforcement of the obligation to pay assessments or other charges set forth in the Association's governing documents; and

- B. An action by the Association to obtain a temporary restraining order or preliminary or permanent injunction (or equivalent emergency equitable relief) and such other ancillary relief as the court may deem necessary in order to enjoin any immediate threat to persons or property; and
- C. Any action between or among unit owners that does not include the Association as a party, if such action asserts a claim which would constitute a claim for relief independent of the Association's governing documents; and
- D. Any action in which any indispensable party is not the Association, its officers, directors, or committee members, or a person subject to the Association's governing documents, or their officers, directors, partners, members, employees and agents; and
- E. Any action involving the Association or the Association's governing documents with a claim value that is less than \$7500; and
- F. Any action to enforce a settlement agreement made under the provisions of this policy.

3. **Judicial Enforcement.** If the parties agree to a resolution of any claim through negotiation or mediation in accordance with this policy, and any party thereafter fails to abide by the terms of such agreement, then any other party may file its action in court to enforce such agreement without the need to again comply with the procedures set forth in this policy. In such event, the party taking action to enforce the agreement shall be entitled to recover from the non-complying party (or if more than one non-complying party, from all such parties as the court may determine) all costs incurred in enforcing such agreement, including without limitation, reasonable attorneys fees and court costs.

4. **Statute of Limitations.** The Claimant need not follow the procedures set forth above if the Claimant would be prejudiced by the running of or lapse of an applicable statute of limitation or statute of repose. In addition, no claim may be initiated after the date when institution of legal or equitable proceedings based on such claim would be barred by the applicable statute of limitation or statute of repose.

5. **Interaction with Enforcement Policy.** It is not the intent of this policy to supersede any of the provisions of the Association's Enforcement Policy. Nor is the intent of this policy to require the Association to

NEW BUSINESS: The dumpster at the South Pool is not being put back properly by Waste Connections and is currently too visible from the street. The Board agreed the ACC should submit plans to build an enclosure for the dumpster. Mark Peterson of WaterKetch, the HOA irrigation contractor, introduced himself to the Board and gave a brief history of his work for Homestead. He noted that when he was first hired at Homestead he spent all his time repairing the system. Since the Association made the commitment in 2008 to renovate sections of the system, the repair work has decreased accordingly. As Homestead renovates sections of the irrigation system, the repair costs decrease and the Association is able to keep the turf green with less water. Mark proposed reducing the repair & maintenance budget and increasing the renovation budget. He also stated it was better for him to renovate during the fall because of weather conditions than try to renovate in the spring when weather remained volatile and systems needed to be turned on. He asked that he be allowed to start the 2014 renovations in the fall of 2013, delaying payment to WaterKetch until 2014. The board made no decision on the reallocation of funds but did agree that Mark should be paid for renovation when he did the renovation and not have to wait for payment until the next year.


