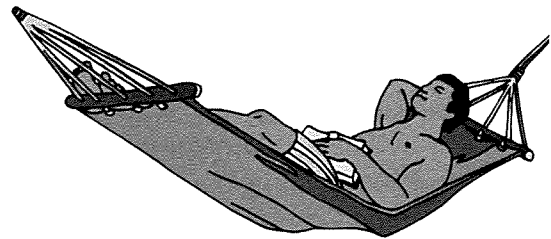
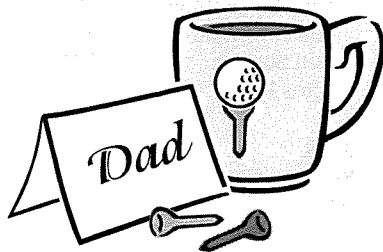

Architectural Control Notice

Homeowners are required to submit an "Application for Architectural Change" form to the HOA if you are planning to make updates, replacements or other improvements to the exterior of your home or property; even if you are replacing or updating with similar products or the same paint colors. Anything visible on the outside of your house or within the yard must be submitted for approval to the Architectural Control Committee (ACC) as our covenants require.

Applications must be accompanied by complete plans, sketches, samples, color chips and/or other pertinent information so that the ACC has as complete an idea of your project as possible. When requesting fence changes, sheds, accessory buildings, or play structures, also submit a drawing of your yard showing the location of the fence or item and indicate the material, height and style of the proposed fencing, shed or structure.

COVENANT REVIEW TASKFORCE

The Covenant Review Taskforce will be walking the community to review all homes and property in June, helping to ensure that properties are maintained and that our high standards of value are retained. Now is the time to review the conditions the Taskforce looks for and make improvements.

HOUSE CONDITION:

- Paint - faded or blotchy
 - chipping and peeling
- Siding - rotting or deteriorating
 - holes in view
- Window frames - rotting
 - paint chipping
- Shutters - broken vanes
 - paint chipping
 - no shutters on the house.
- Garage doors - paint peeling or chipping
 - in general disrepair
- Roof - missing shingles
 - gutters missing or deteriorating
- Satellite Dish - exposed to street view
 - wires exposed
- Driveway - heaved and buckled
 - heavy oil stains

PROPERTY CONDITION:

- Dead Branches & Trees - 50% or more dead branches on one or more trees
 - dead tree or trees
- Shrubs/Vegetation -wild & unkempt
 - overrun with weeds
 - shrubs blocking sidewalk
- Lawn - 40% or more weed infested (dandelions, etc.)
 - dirt patches
- Fence - falling down
 - missing boards or rails
 - pulling away from house
- Trash cans - stored in view
- General debris - stored around house or porch
- Mail box—leaning or crooked
- Commercial or stored vehicles parked in view

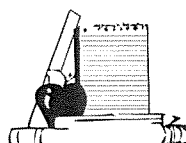

HOMESTEAD IN THE WILLOWS HOMEOWNERS ASSOCIATION

Regular Board Meeting May 10, 2011 – Unofficial Minutes

CALL TO ORDER: Board President, Reed Richardson, called the meeting to order at 6:33 p.m. Board Members present were Aloah Kincaid, Christopher Molke, Chris Raab and Bill Shelden; as well as Business Manager, Katie Kidwell; Pool Manager, Jaylene Jones; Landscape Manager, Nancy Bauer; Tennis Manager, Melissa Shuck; and Swim Team Parent Representatives Paul Russell and Matt Thomas. Homeowners Greg Cromer and Kenneth Morgan attended portions of the meeting as well.

MINUTES: The minutes of the February 8th and April 12th regular meetings were approved as read.

SWIM TEAM: Parent Reps, Paul Russell and Matt Thomas, announced that 227 swimmers had registered for Swim Team. The practice schedule and parent party dates would be published in the June Herald. Tryouts for new swimmers would be held on May 16th. Regular practice would begin on May 18th.

FINANCIAL REPORT: Treasurer, Aloah Kincaid had reviewed the preliminary draft of the 2010 Audit and found it satisfactory. The Board agreed to sign the management representation letter for 2011. The Operating Fund owed the Reserve Fund \$188,962 of cumulative surplus over the last two to three years. With the 2010 Audit finalized, the Board discussed transferring \$188,962 from the operating fund to the reserve fund bringing the reserve fund total to \$341,047. Aloah moved and Chris Molke seconded that Bookkeeper, John Fitzgerald transfer the funds. The motion passed unanimously. Expenses for the month of April totaled \$46,081.

HOMEOWNER COMMENTS: Mr. Greg Cromer presented the Board with a letter protesting the possible placement of wireless antennae on an Xcel power pole located just southwest of the Quebec/Dry Creek intersection behind several homes on S. Pontiac Way. Mr. Cromer stated that the affected neighbors do not want anything placed on the power pole and that if Xcel chose to allow the antenna, he and his neighbors wanted the HOA to send a letter to the Planning Commission formally protesting the placement of the antenna on that particular pole. Chris Raab stated that to date the HOA had only been approached by a company called LightSquared about leasing HOA property for an equipment box. The HOA could not keep Xcel from putting an antenna on their power pole, and if Xcel chose to do so, the lease income from the equipment box would benefit the entire community. Reed stated that the Board members were volunteers who made decisions in the best interest of the community. Through careful management the Board had held the 2011 dues to the 2010 level and any financial compensation from LightSquared for leasing HOA property would benefit all 898 members of the HOA.

Mr. Kenneth Morgan approached the Board about a Covenant issue.

MANAGER REPORTS

1. **POOL:** Pool Manager, Jaylene Jones, reported that the South Pool was filled and circulating. A corner of the shallow end of the North Pool had a hollow area behind the tiles that Front Range had fixed. The concrete near the North Baby Pool would be poured the week of May 11th if weather permitted.

2. **LANDSCAPE:** Landscape Manager, Nancy Bauer, reported that painting of the perimeter fence was scheduled to begin May 13th; affected homeowners had been notified. Because of the dry winter, many areas of sod would need to be replaced. Nancy was working closely with WaterKetch to make sure the grounds were green but not overwatered. In repairing a failing underground line on the West side, Xcel had damaged several sections of concrete. Nancy would work with Xcel's restoration team to have the sections repaired. Xcel had also broken sprinkler lines which had to be repaired. Nancy planned to work on the entry beds and flower pots for the pools during the next few weeks.
3. **TENNIS:** Tennis Manager Melissa Shuck announced that schedules had been posted at each court location. The rebound net at the North Courts would be replaced later in the month when the courts were surfaced. The grounds crew had been instructed to blow grass and leaves off the courts weekly. Chris Molke mentioned there was a great Friday night mixed doubles league organized by the tennis community. Chris Raab praised the work of Vicki Sutherland in putting together that mixed doubles league and commented that the Homestead tennis community seemed to be coming together nicely in support of that type of homeowner-led program organization.
4. **BUSINESS:** Business Manager, Katie Kidwell, reported that of the 48 homeowners who received 2nd notices regarding dues payments, only 26 had responded. Additionally two of the homeowners on payment plans had missed their scheduled payments. The Board discussed that failing to pay dues was a covenant violation and that without the funds from those homeowners the 2011 Budget would not be sufficient to pay for the maintenance of the property. The Board directed Katie to include the fine schedule in the final dues request letter sent to homeowners and to begin applying fines to unpaid balances after June 1st. Katie reported that trash dumpsters had been installed at the pool locations for the summer and that Dumpster Day and Electronic Recycling would occur on Saturday, May 21st.
5. **COVENANT REVIEW TASKFORCE:** Katie read a written report from the taskforce. A meeting had been held in early May and the task force decided the review will take place June. The group would review and make comments on a copy of the homeowner letter prior to walking and Kate Botkin would divide up the community into sections and call another meeting the first week in June to distribute checklists and designated areas.

OLD BUSINESS: Reed reported that David Struthers had sent his proposed changes to the lease agreement to John Marriott of LightSquared, but had heard nothing back from Mr. Marriott. The Service Agreement with Comcast had to be re-notarized and Homestead should receive a signed copy within another month. Katie reported that the HOA attorneys continued to aggressively defend the Association in the case of Dunbar & Horneck v. Homestead in the Willows, HOA. The trial was currently set for August 29, 2011 for a five day jury trial. The parties had exchanged the initial disclosures, and depositions in the matter were about to occur. The plaintiffs had endorsed an expert to opine in support of their case. The HOA's expert disclosures were not yet due, so they had not yet been provided. The HOA insurance company continued to pay attorneys fees in the matter, which

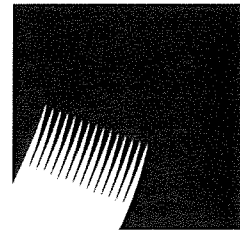

were accruing.

NEW BUSINESS: Aloah moved and Chris Raab seconded that the HOA retain accountants Brashier & Foss to perform the 2011 audit. The motion passed unanimously. The Board reviewed additions to the Residential Improvement Guidelines that included a provision making homeowners who damaged property while remodeling their homes to repair the property; and the inclusion of further explanatory language about the sizing of shutters. Chris Raab moved and Chris Molke seconded that the amendments to the Residential Improvement Guidelines be accepted. The motion passed unanimously.

ADJOURNMENT AND CALENDARING:

Chris Raab moved and Chris Molke seconded that the regular meeting adjourn at 8:26 pm. Motion passed. The Board moved into Executive Session at 8:27 pm to discuss the homeowner appeals. The next regular Board Meeting will be on Tuesday, June 14th at 6:30pm at the Business Office.

LANDSCAPE LOGIC

Maintain your lawn with battery-powered equipment

Would you like never again to fill your lawnmower up with gas? If so, your day has come.

There are now reliable alternatives to the traditional gas-powered lawnmowers and other yard maintenance equipment. With the cost of gas rising and more of us concerned about reducing emissions, the timing is right for these greener machines to hit the market. Well-known manufacturers like Toro, Green Works, Black & Decker and Stihl have all introduced battery-operated lawnmowers. Other battery-powered yard tools like trimmers, blowers and hedge trimmers are also available. In addition to no emissions and quieter operation, these products are very user-friendly because they take little to no maintenance. There's no more changing the oil or replacing spark plugs and air filter. And there's never a worry about gas getting stale and damaging the carburetor.

When you add up the cost savings on maintenance alone over the life time of the equipment, battery powered is very cost effective. When you add up the time you save by not doing these maintenance chores, battery powered is time productive.



Be Water Wise This Summer

Did you know more than 50 percent of summer water use is on landscapes? Follow Denver Water's summer watering rules to reduce waste and save money.

In 2011 Denver Water will continue to enforce

watering rules*, so please use water wisely.

*Lawn watering is NOT allowed between 10 a.m. and 6 p.m. — water during cooler times of the day.

*Water no more than three days per week.

*Do not allow water to pool in gutters, streets and alleys.

*Do not waste water by letting it spray on concrete and asphalt.

*Repair leaking sprinkler systems within 10 days.

*Do not irrigate while it is raining or during high winds.

*Use a hose nozzle with a shut-off valve when washing your car.

Tree Circles

Tree circles are rings around the trunk of a tree devoid of vegetation. This can be accomplished in several ways. Sod and weeds can be dug out, being careful not to damage tree roots, or "Round Up" can be applied carefully in a circle. This should be done three times a year as grass and weeds will grow into an area of dirt without treatment.

There are a number of reasons to establish tree circles. The primary one is to protect the trees.

Other reasons:

*It makes mowing easier

*Mowers do not have to slow down as they are away from the tree.

*The weed whip is eliminated from attacking the trees

*Grass growing against the trunk allows insects a place to hide. Tree circles eliminate this hazard. Grass against the trunk keeps moisture close to the bark. This causes the bark to rot.

Once rings are established wood mulch should be added to mitigate temperatures, conserve moisture, add nutrients to the root zone, and to improve the appearance of circles.

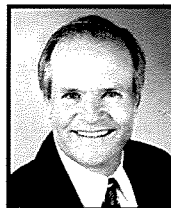

THE MOSQUITOES ARE HATCHING!!!

By John T. Skalet, Homestead's self proclaimed mosquito and heartworm expert

Have you noticed that each year we seem to have more mosquitoes, especially last year? The mosquito population is partially dependent on how much moisture an area receives naturally but out here in the plains, it has more to do with urban sprawl and standing water caused by sprinkler systems filling bird baths, garbage can lids and wading pools.. Standing water in wheel barrows, clogged gutters, buckets, watering cans, flower pot saucers and outside dog dishes are a problem if not rinsed out daily and freshened. Also, the larger our shade trees get, the longer water stands in these objects. That is important because mosquito larvae (eggs) need only two weeks in standing water to hatch. One bird bath can produce 10,000 mosquitoes in just 1 two week period. One female lays 2700 eggs in her 100 day lifespan, that's about 6 or 7 hatch periods. So start swatting every one you see now. Each female you get now is like swatting 2700. You might say, so what, the bites are just a little annoying. The problem is that mosquitoes infect dogs, cats, people and other mammals with encephalitis, west nile, whipworm, roundworm, and heartworm. Yes!!! people are injected with heartworm larvae by the stinger of a mosquito that has bitten a heartworm positive dog or cat. Fortunately, the human immune system usually kills off the fertilized larvae (egg) before it becomes a worm living in your heart. If you don't think we need to worry about heartworm here in Colorado, ask your vet, he or she will tell you that a lot of heartworm positive animals have been transported here from other parts of the country like New Orleans following Katrina. I personally adopted a wonderful dog last year from a Michigan animal shelter knowing that she was heartworm positive. I met her on EHarmony.com. Believe me, you don't want to take an animal through the cure. Make sure that you give your dogs and cats Heartguard or Heartguard Plus once a month from 30 days after you see the first mosquito (which is now) until 30 days after you see the last one. The other worms that mosquitoes spread are more manageable and easier to eliminate and are not as serious a problem in Colorado. Heartworm normally kills a dog or cat in about 5 years, sometimes quicker if the animal keeps getting bitten by more heartworm positive mosquitoes, and it is a horrible death for them. It costs about \$30 to have your dog or cat tested for heartworm and I recommend that everyone do it annually so that the cure can be administered as early in the animal's life as possible. The cure is three shots of an arsenic based serum called Immiticide and it is very painful for the animal and the fatality risk is greatest when the dead worms flow in the blood stream from the heart to the lungs.

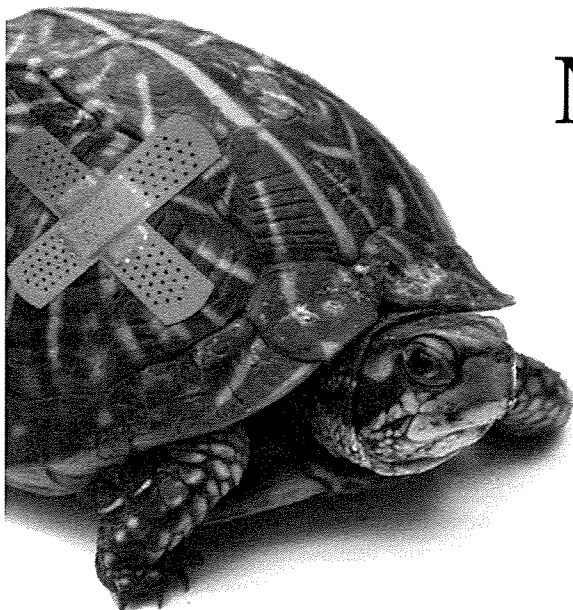
If mosquitoes happen to like you and the itching makes you crazy! (by the way, only one person in every 10 are sweet enough to be attractive to a mosquito) cook the bite with a hair dryer as soon as you feel the first itch. Make it as hot as you can stand for about a minute. You will need to do it one more time 24 hours later when it starts itching again and that's it. You don't believe me do you? It works, I'm from Minnesota, I know these things. It breaks down the protein in the mosquito saliva and the protein is what we are allergic to.

SO PLEASE, during April, May, June and July!!!

- 1 turn your bird baths upside down**
- 2 make sure your gutters don't have standing water**
- 3 turn the kids wading pool upside down**
- 4 take the dog's water dish inside or change it daily, take the dog food dish in also because flies lay their eggs on solid food and you know what fly eggs turn into**
- 5 don't leave garbage can lids upside down**
- 6 drain flower pot saucers**
- 7 get rid of anything else that holds standing water that I haven't thought of**

I hope your summer dinners on the patio are mosquito free!!!

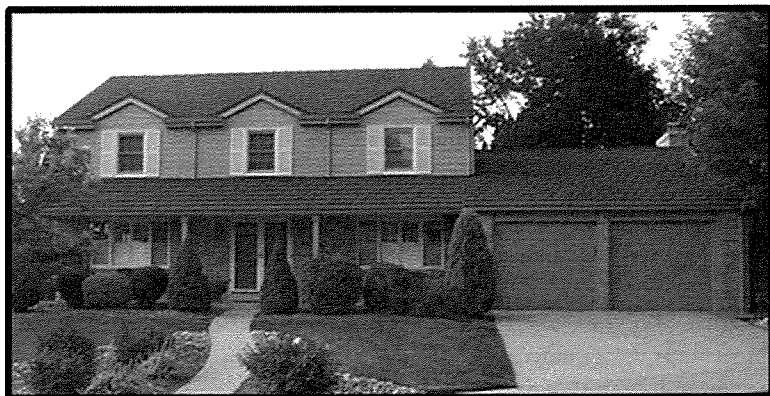

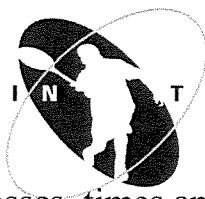

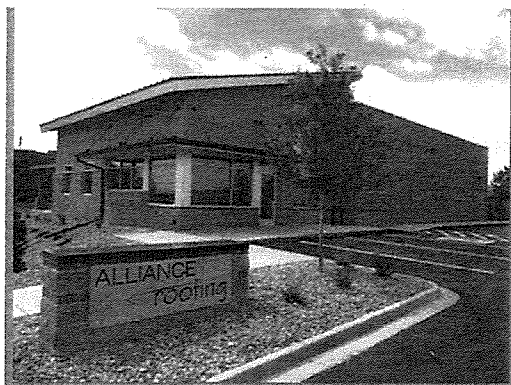

TENNIS RULES for Year 2011

COURT REGULATIONS

A. Proper tennis shoes must be worn by all persons entering the court enclosures. A proper tennis shoe is one that is made primarily for the purpose of playing tennis -- NO BLACK-SOLED SHOES. No jogging or basketball shoes will be allowed. Any person wearing improper shoes will be asked to leave the courts.

B. Proper attire includes shirts and shorts (or tennis skirts) -- no bathing suits. Players not wearing shirts will be asked to put a shirt on or leave the courts.

C. Children under 9 years of age will be permitted to use the courts only when accompanied by a parent or responsible adult. Non-playing children must remain outside the court enclosure for their safety and as a courtesy to others.

D. Pets are not allowed inside the court enclosure.

E. **To avoid damage to the playing surface: smoking, eating, and drinking (except water) are prohibited inside the court enclosure. Tennis ONLY -- no skate boards, roller skates, roller blades, or bicycles are allowed on the courts at any time. VIOLATORS WILL BE PROSECUTED!**

F. Courts are to be locked at all times. Please remember your KEY.

G. Snow may be removed from courts using squeegees and brooms ONLY. No shovels or other hard or sharp objects are to be used due to severe damage to court surfaces.

PLAYING TIMES AND PRIORITIES

A. The HOMESTEAD TENNIS PROFESSIONALS (Rocky Mountain Tennis Academy) HAVE WEST COURT #1 available for their use, when needed, for lessons, drill classes, etc. At some times the use of West Court #2 will be necessary for drill classes.

B. The tennis year will be divided into two parts with each part having its own prime time schedule. This does not apply to those courts reserved for ladies' interclub, jr. interclub, mens' night, ladies' night, jr. lessons, etc.

1. While school is in session, all adult and children association members may have access to the courts with equal priority to 5 p.m. on non-holiday weekdays and AFTER 2 P.M. ON HOLIDAYS AND WEEK-ENDS. Holidays are defined as Memorial Day, the Fourth of July, Labor Day, Thanksgiving, and Christmas. During prime time (after 5 p.m. on weekdays and until 2 p.m. on holidays and weekends), adults have priority. Children under 18 may play during prime time, but may be bumped.

2. During summer vacation from school, all adult and children association members may have access to the courts with equal priority to 4 p.m. weekdays. During prime time (after 4 p.m. weekdays and all day holidays and weekends), adults have priority. Residents under 18 may play during prime time, but may be bumped.

NOTE: "BUMPING" IS DEFINED AS FINISHING THE CURRENT GAME PLUS A 12-POINT TIE BREAKER, IF REQUIRED.

C. When courts are full and others are waiting, please abide by the following procedure:

1. The first court occupants to finish a SET (not a match) will give up their court and go to the bottom of the waiting list of those people physically located at the court at that time.
2. The player(s) at the top of the waiting list will then go to the court most recently vacated and play ONE SET.
3. This rotation will continue on all courts until players are no longer waiting. NOTE: The 12-point tie-

breaker should be used if games reach 6-6. Warm-up time before starting a set should be limited to ten minutes. If you are not going to play a set and just want to practice hitting balls, practice should be limited to 30 minutes.

4. Whenever courts are full and people are waiting, doubles play is strongly encouraged. General courtesies should be followed at all times.

GUEST PRIVILEGES

A. Guests are welcome, but must be playing with a homeowner.

B. A house guest is always welcome and is considered a member.

C. Please be aware that the courts are for Homestead Homeowners and be considerate about the frequency in having guests.

SPECIAL EVENTS

A. The Tennis Board Liaison reserves the right to schedule the courts for special events, such as tournaments and league use.

B. Special events will be posted on the tennis court bulletin boards about 2 weeks in advance. Interested players are urged to participate.

MISCELLANEOUS

A. These rules are subject to change.

B. Any complaints or suggestions should be submitted to the Tennis Board Liaison.

RESERVING PLAYING TIME

The **ONLY** reserved playing time this season is indicated on the Master Court Schedule posted at the North, South and West Courts, and also detailed online. Otherwise, NO **PRIVATE** RESERVED playing time is available, and **no homeowner is permitted to reserve the courts for any reason without prior authorization from the Tennis Board Liaison.**
